

PRIVACY NOTICE OF THE BUDAPEST UNIVERSITY OF TECHNOLOGY AND ECONOMICS CENTRE FOR HIGHER EDUCATION AND INDUSTRIAL COOPERATION FOR SHORT FILMS

In accordance with the General Data Protection Regulation 2016/679 of the European Parliament and of the Council ("GDPR") and Act CXII of 2011 on the Right to Information Self-Determination and Freedom of Information ("Act on Information"), the Budapest University of Technology and Economics informs the persons ("Data Subject") in BUDAPEST UNIVERSITY OF TECHNOLOGY AND ECONOMICS CENTRE FOR HIGHER EDUCATION AND INDUSTRIAL COOPERATION's short films about the processing of personal data:

2. THE PURPOSE OF THE PROCESSING

The main purpose of the data processing is the production of short films with the participation of natural persons presenting, informing, informing and promoting the University's Centre for Higher Education and Industrial Cooperation an additional processing purpose related to the mainpurpose is the identification of the Data Subjects in connection with their statements, and the maintenance of contact.

The University aims to present the Centre for Higher Education and Industrial Cooperation, its projects (primarily the NKFIH FIEK_16-1-2016-007, call for proposals 2019-1.2.1-EGYETEMI-ÖKO), its sub-projects, the organisation's departments, its values and a topic related to its activities in a clear and understandable way, thus increasing the awareness of the given topic, the social recognition of science and the popularity of the University and FIEK.

3. LEGAL BASIS FOR DATA PROCESSING

The processing is based on the voluntary consent of the Data Subjects in the FIEK short film [Article 6 (1) (a) GDPR], taking into account the provisions of Article 2:48 of Act V of 2013 on the Civil Code.

4. CATEGORIES OF PERSONAL DATA PROCESSED, THEIR SOURCE

4.1 In relation to the data subjects interviewed in the short films:

- name, title
- institution / company represented
- screenshot
- voice.

4.2. For those stakeholders who are not voiced in the short films:

- screenshot.

4.3. In addition, in relation to each Data Subject, the Data Subject's consent to:

- natural person identification data (name and surname, name and surname at birth, place of birth, date of birth and mother's name and surname at birth)
- e-mail
- his/her signature.

5. THE METHOD OF DATA PROCESSING

Prior to the shooting of short films, the University provides information to potential actors of short films by means of this Privacy Policy, who are free to decide, without any influence, whether they wish to appear in a specific short film of BME FIEK and whether they consent to its use. The University guarantees that those who do not wish to be filmed will not be penalised in any way.

The University will process the prior written consent of the Data Subjects on a paper basis.

The short films are digitally recorded, and their use, distribution and public communication will be primarily on the University's publicly accessible websites, social media platforms, events, lectures, information materials about the University, BME FIEK, University publications, but the University may also grant permission to others to communicate the short films to the public.

The name, title, function, job title, position and the name of the institution or company represented by the Stakeholder will be displayed in the short films.

6. DURATION OF PROCESSING

Until the Data Subject's consent is withdrawn, or in the absence thereof, the University shall be entitled to use the short films produced and to broadcast them to the public without any time limit.

The University shall process the consent forms for the same period as the short films.

7. DATA PROCESSOR, RECIPIENTS OF PERSONAL DATA PROCESSED

The University uses a Data Processor for the production of short films:

The Data Processor will process the personal data of the Data Subjects as defined in points 4.1 and 4.2 for the production of the short films.

The University will make the short films available to the public, so that the personal data of the Data Subjects included in the short films can be accessed by viewers of the short films, including viewers in third countries, and by employees of organisations to which the University has given permission to broadcast the short films.

Only authorised University employees may access personal data provided in the consent form that is not displayed in the film in order to carry out their duties.

8. RIGHTS OF THE DATA SUBJECT, REMEDIES

When processing your personal data, you have the rights set out in the GDPR.

You may exercise your rights in relation to the processing of your personal data by the Data Controller by writing (electronically or by post) to the contact details of the Data Controller provided in point 1.

The Data Controller will not provide information about the Data Subject's personal data or receive instructions concerning personal data by telephone. Therefore, only general information will be provided by telephone.

The University will inform you of the action taken on your request, the reasons for non-action or refusal of your request and the remedies available to you within 30 days of receiving your request, which may be extended by a further two months if necessary, taking into account the complexity of the request and the number of requests. The University will inform you of any extension and the reasons for it within 30 days of receipt of the request.

The University shall, as a general rule, ensure the exercise of the right of access free of charge. However, if the request of the data subject is manifestly unfounded or excessive, in particular because of its repetitive nature, the University shall, subject to the administrative costs of providing the information or information requested or of taking the requested action:

- (a) charge a reasonable fee; or
- (b) refuse to act on the request.

8.1 Transparent information

The University will inform the Data Subjects in this document about the identity and contact details of the Data Controller, the contact details of the Data Protection Officer, the purposes, legal basis and duration of the processing, the rights of the Data Subjects and the possibility of legal remedies.

8.2. Access to personal data

At any time, you have the right to request information from the University at the contact details provided in Section 1 whether your personal data are being processed and, if such processing is ongoing, you have the right to access your personal data and the information specified in the GDPR, Infotv.

8.3 Corrections, additions

At any time, you have the right to request the amendment, correction or completion of personal data concerning you at the University's contact details provided in section 1.

The Data Controller will promptly make the correction or addition to its records and will notify you of the correction or addition orally in person or, in other cases, in writing (by electronic mail or post).

8.4. Withdrawal of consent

Your consent will be revoked by the BME Centre for Higher Education and Industrial Cooperation 1111 Budapest, Bartalan Lajos u. 2. 9. floor. 906. by post or by e-mail to fiek@bme.hu.

The withdrawal of consent does not affect the lawfulness of the processing based on consent prior to its withdrawal.

8.5. Cancellation

You have the right to request the deletion of personal data concerning you at the University's contact details provided in section 1 in the cases set out in the GDPR. The University will examine your request and, if justified, take action to delete it.

The University shall reject the request for erasure in the cases provided for in Article 17(3) of the GDPR, in particular in cases where the University, as the Data Controller, is required by law or by internal rules based on law, in particular the rules on data management, to continue to store the personal data or where the processing is necessary for the establishment, exercise or defence of legal claims.

8.6. Limitation of processing

You have the right to request the restriction of personal data relating to you at any time using the University's contact details provided in Section 1, if the conditions set out in the GDPR are met. For example, if the University no longer needs the data or there is a possible unlawfulness of the processing, but you object to its erasure and request instead that the use be restricted.

Personal data subject to restriction may be processed only with your consent or for the establishment, exercise or defence of legal claims or for the protection of the rights of another natural or legal person or for important public interests of the Union or of a Member State.

8.7. Objections

The University may object to the processing of your personal data on the contact details provided by the University in Section 1 for reasons relating to its own situation, if the University would do so on the legal grounds set out in Article 6(1)(e) or (f) of the GDPR, i.e. for the performance of a task carried out in the public interest or in the pursuit of a legitimate interest stated or for direct marketing purposes. In this case, the personal data may only be further processed despite the objection if the processing is justified by compelling legitimate grounds which override the interests, rights and freedoms of the Data Subject or for the establishment, exercise or defence of legal claims.

8.8 Right to automated decision-making, profiling

No automated decision making or profiling will take place in the processing of data related to BME FIEK short films.

8.9. Data portability

If the processing is automated and based on the data subject's consent or necessary for the performance of a contract entered into by the data subject or for the preparation of such a contract, it is the responsibility of the controller to provide the data subject, upon the data subject's request, without undue delay, with personal data concerning the data subject that the data subject has provided to the University in a structured, commonly used, machine-readable format. The Data Subject shall have the right to transmit such data to another controller without hindrance from the controller to whom the personal data have been provided.

The Data Subject may request the direct transfer of personal data between controllers.

The right to data portability shall not apply where the processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the University.
